BE IT ORDAINED by the Township Council of the Township of Deptford, that a certain paragraph of Chapter VI, Section 3 entitled "License Fees; Maximum Number" of the Alcoholic Beverage Control Ordinance of the Revised General Ordinances of the Township of Deptford, shall be amended as follows:

6-3.4 License Fees; Maximum Number.

The license fee for a Plenary Retail Consumption License shall be amended and increased to read "\$2,052.00".

The license fee for a Plenary Retail Distribution License shall be amended and increased to read "\$856.80".

The license fee for a Club License shall be amended and increased to read "\$75.60".

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances inconsistent with or contrary to the provisions of this Ordinance amendment are hereby repealed to the extent of any such inconsistency.

BE IT FURTHER ORDAINED that this Ordinance shall become effective twenty days after the final adoption and publication according to the laws of the State of New Jersey.
