

**ORDINANCE OF THE TOWNSHIP COUNCIL
OF THE TOWNSHIP OF DEPTFORD ESTABLISHING
THE DEPTFORD TOWNSHIP POLICY MANUAL
FOR NOTARY PUBLIC AND FEE FOR SERVICE**

BE IT ORDAINED by the Mayor and Council of the Township of Deptford hereby adopting and establishing the Deptford Township Policy Manual for Notary Public, a copy of which is incorporated herein and appended hereto.

BE IT FURTHER ORDAINED by the Mayor and Council of the Township of Deptford, as follows:

1. Consistent with Chapter 7, Title 52 of Statute of New Jersey a \$2.50 fee shall be charged per document for Notary services provided by the Township.
2. The Notary Policy shall supersede any and all previous Policies established for Notary Public.
3. Upon adoption copy of the Deptford Township Policy Manual for Notary Public shall be distributed to all registered Notary Public employed by the Township.
4. Upon adoption copy of the Deptford Township Policy Manual for Notary Public shall be distributed to all Deptford Township Department and Division Heads.
5. If any section, or part thereof, of this Ordinance shall be deemed invalid, the remainder of this Ordinance shall be deemed valid and effective.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon passage and publication as required by law.
