ORDINANCE AMENDING CHAPTER 7 OF THE TOWNSHIP CODE (TRAFFIC) PROHIBITING PARKING, STOPPING OR STANDING ON WHITE MARSH DRIVE AND TALL PINES DRIVE AND BE FURTHER AMENDED BY PROVIDING PARKING PERMIT EXEMPTIONS

WHEREAS, the Township Manager and Police Department has reviewed the traffic conditions on White Marsh Drive and Tall Pines Drive; and

WHEREAS, is has been determined that property owners of the Loucroft Farms development would be adversely effected prohibiting stopping, standing and no parking on White Marsh Drive and Tall Pines Drive from 8:00AM to 4:00PM except Saturdays, Sundays and holidays;

WHEREAS, the Township Manager and Police Department upon conducting a field survey and interviews of property owners identified do hereby recommend that said property owners having vehicles registered through the New Jersey Division of Motor Vehicles and residing in the Loucroft Farms development be exempt from the revisions as set forth in Section 7-10 and Section 7-14 of Chapter 7 of the Revised General Ordinance of the Township entitled, Traffic; and

WHEREAS, the Township Manager and Police Department recommends that permit parking permits be issued to residents/property owners having notified residents of the Loucroft Farms development and be exempted from the provisions of Chapter 7 entitled Traffic; and

NOW, THEREFORE, BE IT ORDAINED, by the Township Council of the Township of Deptford, County of Gloucester that Chapter 7 of the Revised General Ordinance of the Township (Traffic) is hereby amended to read as follows:

SECTION 1. Section 7-10 and Section 7-14 are to read as follows:

Property owners of the Loucroft Farms development are hereby exempt and shall be issued an annual parking permit. Owners of said properties and individuals occupying same shall be required to register with the Police Department annually and be issued parking permit exemptions pursuant to rules and regulations adopted by the Chief of Police of the Township of Deptford compliant with N.J.S.A. Title 39:1 et. seq.

SECTION 2. Any provisions of any Ordinance inconsistent with the provisions of this Ordinance are hereby repealed.

SECTION 3. If any sections or provisions of this Ordinance shall be ruled invalid, such ruling shall apply only to the sections or provisions ruled invalid and the remainder of the Ordinance should be deemed valid and remain in full force and effect.

SECTION 4. This ordinance shall take effect twenty days after the final passage pursuant to N.J.S.A. 40:69A-181.
