AN ORDANANCE OF THE TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER AMENDING ORDINANCE SECTION 7-27 "TURN PROHIBITIONS" IN THE TOWN OF DEPTFORD, COUNTY OF GLOUCESTER, STATE OF NEW JERESY TO WIT: NO LEFT TURN AT THE SOUTHERN MOST DRIVEWAY OF STATE HIGHWAY ROUTE 41 – HURFFYILLE ROAD, SEWELL, NJ 08080

ADDRESS: SEVEN STAR PLAZA, 1890 HURFFVILLE ROAD, SEWELL, NJ 08080, TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY BLOCK 387.01, LOTS 76, 78 & 79

WHEREAS, the Country of Deplord, Country of Gloucester, New Jersey ("Township") has heretofore duly and finally adopted Amended Ordnance Section 7-27 prohibiting left turns at the proposed Route 41 southerly driveway, and

WHEREAS, the Township is desirous of amending Section 7-27 of the Ordinance to expand the purposes set forth therein.

NOW, THEREFORE, BE IT ORDAINED, BY THE TOWNSHIP COUNCIL (NOT LESS THEN TWO-THIRDS OF ALL THE MEMBERS THEREOF AFFIRMATIVELY CONCURRING), AS FOLLOWS:

Section 1. Section 7-27 Turn Prohibitions is hereby amended to prohibit left turn at the proposed Route 41 southerly driveway. The access scheme shall hereby consist of one full movement and one right-in/right-out driveway to Route 41. Additionally, the access scheme for Route 47 shall consist of one full movement driveway and one ingress driveway.

Section 2. If any Section, Subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by a Court of competent jurisdiction, such portion shall be deemed a separate and distinct and independent provision, and such holdings shall not affect the validity of the remaining portion hereof.

Section 3. Any and all ordinances inconsistent with this ordinance, in whole or part, are hereby repealed to the extent of their inconsistency.

Section 4. This Ordinance shall take effect upon passage, approval and publication as required by law and the Township's Council Members.
