AN ORDINANCE AMENDING REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF DEPTFORD, CHAPTER VII, SECTION 7-13, ENTITLED, "PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS" WITHIN THE TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY

WHEREAS, the Mayor and Township Council of the Township of Deptford, County of Gloucester, deems it necessary to amend traffic regulations.

NOW, THEREFORE, be it ordained by the Mayor and Township Council of the Township of Deptford, County of Gloucester, that Chapter VII of the Revised General Ordinances of the Township of Deptford entitled, "Parking Prohibited at All Times on Certain Streets" is hereby amended to read by adding the following location:

SECTION 1. Section 7-13 is hereby amended to read as follows:

Lippincott Avenue	Zone 1	West	Certain areas designated as the west side of Lippincott Avenue between Park Avenue and Fisher Avenue to be designated as no parking.

SECTION 2. Any provisions of any Ordinance inconsistent with the provisions of this Ordinance are hereby repealed.

SECTION 3. If any sections or provisions of this Ordinance shall be ruled invalid, such ruling shall apply only to the sections or provisions ruled invalid and the remained of the Ordinance should be deemed valid and remain in full force and effect.

SECTION 4. This Ordinance shall take effect twenty (20) days after final passage pursuant to N.J.S.A. 40:69A-181.
