

**ORDINANCE OF THE TOWNSHIP OF DEPTFORD AMENDING CHAPTER 7 OF
THE TOWNSHIP CODE TO PROHIBIT STOPPING OR STANDING ON
ISZARD COURT (CUL-DE-SAC)**

WHEREAS, the Police Department has determined that stopping or standing of vehicles on Iszard Court is prohibited from 7:00AM to 9:00AM and 2:00PM to 4:00PM Monday through Friday so as to address a continuing situation involving the stopping or standing of vehicles thereon, which causes a traffic hazard; and

WHEREAS, the Township Engineer has investigated the circumstances and concludes that the creation of no-stopping and no-standing zones on the identified roadway is in the best interest of the public and approves such action and erection of the appropriate signage; and

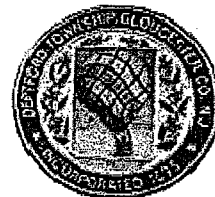
WHEREAS, the Police Department has recommended that a no-stopping or no-standing zone be declared on Iszard Court (Cul-de-Sac); and

WHEREAS, the Mayor and Council agrees with this recommendation;

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Township of Deptford as follows:

SECTION 1. Chapter 7 of the Township Code hereby establishes that no persons shall stop or stand a vehicle at any time on any part of Iszard Court from 7:00AM to 9:00AM and 2:00PM to 4:00PM Monday through Friday.

SECTION 2. This ordinance shall take effect upon adoption and publication pursuant to law.
