# ORDINANCE OF THE TOWNSHIP OF DEPTFORD AMENDING THE TOWNSHIP CODE TO CREATE A DIVISION OF SENIOR SERVICES

WHEREAS, the Township of Deptford (the "Township") recognizes the need for providing services to older adults who are residents of the Township; and

WHEREAS, the Township seeks to streamline the services it currently provides to older adults; and

WHEREAS, the Township strives to continually meet the needs of its senior citizen population; and

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Township Council of the Township of Deptford, in the County of Gloucester and State of New Jersey, as follows:

**Section 1.** Section 2-52 shall be added to the Township Code and shall read as follows:

#### **§2-52DIVISION OF SENIOR SERVICES**

(a) Within the Department of the Township Clerk there shall be a Division of Senior Service, the head of which shall be the Department Head of the Department of Senior Services.


(b) The Division of Senior Services shall coordinate all senior activities, clubs, events and budgets with approval of Township Council.

(c) A director, who shall be appointed by Township Council, shall serve under the department head and shall coordinate events and affairs of the Division of Senior Services.

Section 2. Repealer. All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflict.

Section 3. Severability. If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not effect the remaining provisions of this ordinance. The governing body of the Township of Deptford declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

Section 4. Effective Date. The ordinance shall take effect immediately upon passage and publication according to law.
