ORDINANCE OF THE TOWNSHIP OF DEPTFORD AMENDING TOWNSHIP CODE CHAPTER 19, SECTION 14, RESIDENCY REQUIREMENTS, TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY

WHEREAS, the Township Council of the Township of Deptford in the County of Gloucester, State of New Jersey desires that Chapter 19, Section 14 of the Code of the Township of Deptford be amended; and

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Township Council of the Township of Deptford, in the County of Gloucester, State of New Jersey as follows:

Section 1. Deptford Township Municipal Code Chapter 19, Section 14-2 is hereby repealed in its entirety and is replaced by the following:

All employees and officers employed by the Township after the effective date of this section are required to be bona fide residents therein. However, existing employees or officers employed by the Township who have moved out of the Township prior to the effective date of this section shall not be required to be bona fide residents therein.

Section 2. Deptford Township Municipal Code Chapter 19, Section 14-1 is hereby amended to remove the language "with the exception of Municipal Police Officers" from the definition of "Office and Employee."

Section 3. Repealer. All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflict.

Section 4. Severability. If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance. The governing body of the Township of Deptford declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

Section 5. Effective Date. The ordinance shall take effect immediately upon passage and publication according to law.
