## ORDINANCE OF THE TOWNSHIP OF DEPTFORD AMENDING CHAPTER 7 OF THE TOWNSHIP CODE TO PROHIBIT PARKING AT ALL TIMES ALONG A PORTION OF MARION AVENUE

**BE IT ORDAINED** by the Mayor and Township Council of the Township of Deptford, County of Gloucester, State of New Jersey, as follows:

Section 1. §7-14 of the Township Code entitled "PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS" shall be amended to now include the following street:

## §7-14. PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS.

Section 2. Repealer. All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflict.

Section 3. Severability. If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not effect the remaining provisions of this ordinance. The governing body of the Township of Deptford declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

Section 4. Effective Date. The ordinance shall take effect immediately upon passage and publication according to law.
