ORDINANCE OF THE TOWNSHIP OF DEPTFORD AMENDING §7-13 OF THE DEPTFORD MUNICIPAL CODE TO RESTRICT PARKING ON LEXINGTON AVENUE

BE IT ORDAINED, by the Mayor and Township Council of the Township of Deptford, in the County of Gloucester, State of New Jersey, as follows:

Section 1. Deptford Township Municipal Code § 7-13 shall be amended by the addition of the following language to Municipal Code §7-13:

| Name of Street | Zone | Sides | Hours | Location |

Section 2. Repealer. All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflict.

Section 3. Severability. If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance. The governing body of the Township of Deptford declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law.
