ORDINANCE NO. 413 of 2018 AN ORDINANCE OF DUNCANNON BOROUGH, PERRY COUNTY, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR 2019

WHEREAS, the Borough Council of Duncannon Borough ("Borough"), in an effort to preserve the health, safety, and welfare of its residents, and comply with the applicable Borough Code sections, believes it to be in the best interest of the residents of the Borough to levy real estate taxes as set forth herein; and

WHEREAS, the express intent and purpose of this ordinance is to set the annual real estate tax rate as required by 8 Pa.C.S.A §1310 upon adoption of the annual budget; and

WHEREAS, the Borough Code at 8 Pa.C.S.A §1302(a) authorizes the Borough to levy a tax not exceeding thirty (30) mills for general purposes as elaborated therein; and

WHEREAS, the Borough Code at 8 Pa.C.S.A §1302(a)(b) allows the Borough to levy a tax not exceeding three (3) mills for fire protection purposes as elaborated therein; and

WHEREAS, in conjunction with preparing the 2019 annual budget, the Borough Council has determined that the tax rate for 2019 shall be set at 3.42 mills for general purposes, and raise to .78 mills for fire protection purposes; and

WHEREAS, the Borough Council has adopted its annual budget for 2019 real estate tax rate is set as follows:

- The 2019 real estate tax rate is 3.42 mills for general purposes and .78 mills for fire protection purposes.
- 2. This Ordinance is enacted pursuant to the Borough Code (Act No. 581 of February 1, 1966, P.L. 1956 (1965)), as amended, the laws and the Constitution of the Commonwealth of Pennsylvania, and the Borough Council hereby determines, finds and declares that each and every matter and thing provided for herein is necessary, desirable or proper to promote the public health, safety, morals and general welfare and to carry out and effectuate the public purposes of the Borough in accordance with such laws and the Constitution of the Commonwealth of Pennsylvania.
- In the event that any one or more of the provisions, sections, sentences, clauses or parts contained in this Ordinance shall for any reason be held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provision, section, sentence, clause or part of this Ordinance, and this Ordinance shall be construed and enforced as if such invalid, illegal or unenforceable provision had never been contained herein.
