AN ORDINANCE AMENDING ORDINANCE # 21-30 FIXING THE SALARY CLASSIFICATIONS FOR MEMBERS OF THE SUPERIOR OFFICERS ASSOCIATION (SOA 145A) OF THE TOWNSHIP OF EAST BRUNSWICK

BE IT ORDAINED, by the Township Council of the Township of East Brunswick, County of Middlesex, State of New Jersey according to the following:

SECTION 1. Effective January 1, 2021, the creditable salaries and compensation for certain uniformed Public Safety employees of the Township of East Brunswick shall be fixed by the rank and in the manner established by this ordinance in compliance with the collective bargaining agreement between the Township of East Brunswick and the bargaining unit Superior Officers Association, (SOA 145A).

SECTION 2. The base salary schedule is hereby amended as more particularly set forth below on Schedule A, copies of which are on file in the Municipal Clerk’s Office.

SCHEDULE A

SALARY SCHEDULE FOR CERTAIN UNIFORMED PUBLIC SAFETY EMPLOYEES BY RANK

SECTION 3. Any member becoming or possessing a Drug Recognition Expert (“DRE”) will be provided a base stipend of \$2,500 per year.

BE IT FURTHER ORDAINED, that if any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect, and to this end the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED, that all other ordinances in conflict or inconsistent with this ordinance are hereby repealed, to the extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Township, the provisions hereof shall be determined to govern. All other parts, portions and provisions of the Ordinances of the Township are hereby ratified and confirmed, except where inconsistent with the terms hereof.

BE IT FURTHER ORDAINED, this Ordinance shall take effect twenty (20) days after final passage, adoption and publication according to law.


