ORDINANCE NO. 7 OF 2024

**AN ORDINANCE TO AMEND & SUPPLEMENT CHAPTER 260 ENTITLED  
"VEHICLES AND TRAFFIC"**

**WHEREAS**, the City acknowledges the need to allow for parking so that residents will not receive unnecessary tickets due to the City street-cleaning schedule; and

**WHEREAS**, Article III of the City of East Orange Municipal Code regulates Stopping, Standing and Parking; and

**WHEREAS**, the Mayor and City Council concluded that City residents will be better served by amending the parking schedule to allow for better street-cleaning throughout the City.

**NOW, THEREFORE, BE IT RESOLVED** that Chapter 260 of the City Code is amended as follows:

**SECTION 1.** (Amended Section Only)

**§ 260-15.1 Parking of trucks weighing in excess of 10,000 pounds prohibited.**

No person shall park a truck, tractor, trailer, semitrailer or omnibus having registered gross weights in excess of 10,000 pounds upon any street or parts of street within East Orange, ~~between the hours of 2:00 a.m. and 6:00 a.m. on any day.~~

**SECTION 2: Severability of Ordinance Provisions**

Each section of this Chapter is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective for any cause shall not be deemed to affect the validity or constitutionality of any other sections or parts thereof.

**SECTION 3: Conflict of Other Ordinance Provisions**

All ordinances and parts of ordinances that conflict or are inconsistent with this Chapter are hereby repealed only to the extent of such conflict or inconsistency.

**SECTION 4: Effective Date of Ordinance Provisions**

This Chapter shall take effect upon final passage and expiration of twenty (20) days following publication unless otherwise provided by resolution of City Council.



