INCORPORATED VILLAGE OF EAST HILLS BOARD OF TRUSTEES LOCAL LAW NO. 1 OF THE YEAR 2024

A LOCAL LAW AMENDING CHAPTER 37, SECTION 3A OF THE CODE OF THE INCORPORATED VILLAGE OF EAST HILLS AS IT RELATES TO THE REQUIRED NUMBER OF PROPOSALS FOR NON-BID PROCUREMENT OF GOODS AND SERVICES.

The Board of Trustees of the Incorporated Village of East Hills enacts into local law the following amendment to § 37-3A:

Section 1: Content

Section 37-3 "Method of purchase; required number of proposals." Subsection A is repealed and in its place is enacted the following provision:

§ 37-3 Method of purchase; required number of proposals.

A. The following method of purchase will be used in order to achieve the highest savings, except purchase contracts over \$20,000 and public works contracts over \$35,000; goods purchased from agencies for the blind or severely handicapped; goods purchased from correctional institutions; purchases under state and county contracts; or purchases or services provided pursuant to § 37-5 of this chapter:

Estimated Amount of Purchase Contract	Method
Below \$3,000	No quotations required*
\$3,000 to \$10,000	2 written quotations
\$10,000 to \$19,999	3 Written quotations
Estimated Amount of Public Works/Services Contract	Method
Below \$3,000	No quotations required*
\$3,000 to \$10,000	2 written quotations
\$10,000 to \$34,999	3 written quotations

NOTE:

*Prior to payment for goods or services, an itemized listing of all items purchased and their prices shall be obtained from the vendor and retained in the Village records.

Section 2: Separability

If any section or provision of this local law shall be adjudged to be invalid or ineffective by any Court or competent jurisdiction, such judgment shall not affect, impair or invalidate any other part of this local law or its remainder, and shall be confined in its operation to the section or provision or part of this local law which is directly involved in the controversy in which a judgment was rendered.
