Section 1. Legislative Intent

This Local Law adds Section 250-31 so as to make clear that any person who fails to keep a sidewalk, path and/or public thoroughfare clear to the Code shall be liable to any person who suffers injury or property damage as a result thereof.

Section 2. §250-31 as Amended

§250-31 Failure to repair, maintain or keep clear sidewalks, paths and/or public thoroughfares.

[Added 9-9-1992 by L.L. No. 10-1992]

In the event that the owner and/or occupant of any premises abutting a sidewalk, path and/or public thoroughfare shall fail to comply with the provisions of §\$250-27, 250-28 or 250-30 of this article, and personal injury or property damage shall result from such failure, said owner and/or occupant of the premises shall be liable to all persons who are injured and/or whose property is damaged as a result of such noncompliance.

Section 3. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall

be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.
