A local law Amending Section 275-72 of the Code of The Incorporated Village of East Rockaway to specify that vehicles are not permitted to park between 3:00 a.m. and 5:00 a.m. on all streets within the Village.

Section 1. Legislative Intent

This Local Law amends Section 275-72 of the Code so as to specify that no vehicles may be parked between the hours of 3:00 a.m. and 5:00 a.m. on all streets within the Village.

Section 2. Section 275-72 As Amended

§ 275-72. All-night parking.

A. The parking of vehicles is hereby prohibited on all streets within the Village of East Rockaway between the hours of 3:00 a.m. and 5:00 a.m.

B. The Mayor shall have the authority with the consent of the Village Board to suspend from time to time the provisions set forth in Subsection A herein throughout the Village under such circumstances where it is deemed in the best interest of the Village residents.

Section 3. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 4. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.
