## AN ORDINANCE: AMENDING SECTIONS IN CHAPTER 435, PROPERTY MAINTENANCE AND HOUSING STANDARDS

THE CITY OF EASTON HEREBY ORDAINS:
SECTION 1. Amending Sections in Chapter 435, B (1) Violation ticket fines and B (2) Violation ticket Penalties, be and is hereby amended as per attached Exhibit " A "

> SECTION 2. All Ordinances or parts of ordinances inconsistent herewith be, and the same are hereby repealed.

SECTION 3. This ordinance shall take effect 30 days following adoption by Council.

## § 285-17 Property Maintenance and Housing Standards, Chapter 435.

A. Existing Structures Code. Pursuant to Section ES-112.3, Appeal fees, a fee of $\$ 500$, payable in advance, shall be paid for each appeal taken to the Property Maintenance Board of Appeals from a decision of the Bureau to cover the costs of mailing notices and the hearing of the appeal (§ 435-11). [Amended 9-252013 by Ord. No. 5432]
B. Violation ticket fines and penalties. [Added 7-27-2016 by Ord. No. 5561]
(1) Violation ticket fines. Violation tiekets may be issued in the amount of $\$ 25$ for each violation. a. First violation ticket within a 12 -month period, violation tickets shall be issued in the amount of $\$ 50$.
b. Second violation ticket within a 12 -month period. violation tickets shall be issued in the amount of $\$ 100$.
c. Third violation ticket within a 12 -month period. violation tickets shall be issued in the amount of $\$ 150$.
(2) Violation ticket penalties. If the person in receipt of a violation ticket does not pay the fine or request a hearing within 10 days, the person will be subject to a penalty set forth in this section. $\$ 10$ for days 11 through 20.Failure of the person to make payment within 20 days shall make the person subject to a nontraffic citation in accordance with Chapter 435, 435-1-6.
a. If a person in receipt $\$ 50.00$ ticket is not paid or a request for a hearing is not made within 10 days, a penalty of $\$ 50.00$ for days 11 through 20 would be added. For a total of $\$ 100.00$ on a late ticket.
b. If a person in receipt $\$ 100.00$ ticket is not paid or a request for a hearing is not made within 10 days, a penalty of $\$ 100.00$ for days 11 through 20 would be added. For a total of $\$ 200.00$ on a late ticket.
c. If a person in receipt $\$ 150.00$ ticket is not paid or a request for a hearing is not made within 10 days, a penalty of $\$ 150.00$ for days 11 through 20 would be added. For a total of $\$ 300.00$ on a late ticket.
C. Rooming houses (§ 435-30). The annual permit fee shall be as follows: [Amended 12-12-2012 by Ord. No. 5382]

Number of Units Fee
Less than 10 units $\$ 35$
10 to 24 units $\quad \$ 60$
25 or more units $\$ 110$
