

**ORDINANCE #15-2023**

**AMENDING CHAPTER 198, TITLED PARKS AND RECREATION AREAS  
ARTICLE I, TITLED CITY LAKE PARK, SECTION 16.1 TITLED  
PROHIBITED ACTIVITIES OF THE CODE OF THE CITY OF EGG HARBOR**

**WHEREAS**, the Mayor and Council of the City of Egg Harbor would like to continue to protect the residents of the City; and

**WHEREAS**, pursuant to N.J.S.A. 40: 48-2, a municipality may repeal or amend an ordinance as it deems necessary and proper for good government, order and protection of persons and property and for the presentation of the public health, safety and welfare of its inhabitants.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Egg Harbor that Chapter 198 , Article 1, Section 16.1 Titled Prohibited Activities is amended as follows:

**SECTION 1. Chapter 198-16.1-Prohibited Activities shall be amended to add the following:**

P. No external speakers of any kind, no radios or boom boxes. Only personal listening devices are permitted for music which are ear buds or headphones.

Q. The nature trail gate on Liebig Street and Philadelphia Avenue shall be opened for hunting and gaming seasons pursuant to the yearly schedule set by the NJ Division of Fish and Wildlife.

R. Maximum occupancy for picnic tables is 10 persons, including children. No outside tables are permitted.

**SECTION 2. REPEAL OF PRIOR ORDINANCES.** All ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.

**SECTION 3. SEVERABILITY.** To the extent that any part of parts of this Ordinance are repealed or otherwise modified or voided by State Statute or case law, the remaining portions or sections of this Ordinance shall remain in full force and effect. If any section, sentence or any part of this Ordinance is adjudged, unconstitutional or invalid by a Court of competent jurisdiction, such judgment shall not affect, impair or invalidate the remainder of the Ordinance, but shall be confined in its effect to the section, sentence or

other part of this Ordinance directly involved in the controversy in which judgment shall have been rendered.

**SECTION 4. EFFECTIVE DATE.** This Ordinance shall take effect after final passage and publication as provided by law.
