AN ORDINANCE OF THE BOROUGH OF ELMER, COUNTY OF SALEM,
STATE OF NEW JERSEY REPEALING CHAPTER 3, SECTION 10
BEEKEEPING

WHEREAS, the State of New Jersey Department of Agriculture issued a letter dated July 14, 2023 to all municipalities regarding regulations of beekeeping activities and regulation of apiaries; and

WHEREAS, state law, *N.J.S.A. 40:48-1.5*, prohibits municipalities from adopting ordinances regarding the regulation of keeping honeybees; and

WHEREAS, the Borough Council and Mayor desire to repeal Chapter 3, Section 10 Beekeeping to be in compliance with state law;

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Elmer, County of Salem, State of New Jersey, that it hereby repeals Chapter 3, Section 10 in its entirety:

SECTION 1 – REPEAL

- § 3-10. Beekeeping.
- § 3-10.1 Prohibited.
- § 3-10.2 Violations and Penalties.



BE IT FURTHER ORDAINED, that all other sections of Chapter 3 shall remain in full force and effect.


