AN ORDINANCE AMENDING PORTIONS OF THE CITY'S TRAFFIC CODE RELATED TO GOODE DRIVE.

WHEREAS, at the October 5 and November 2, 2023, Committee Meetings, discussion was held relating to safety concerns regarding excessive cut through traffic on Goode Drive, which is not wide enough for two vehicles to pass each other; and

WHEREAS, upon review by City staff and the St. Louis County Police Department, recommendation was made to change Goode Drive from "local traffic only" to a "no through traffic" designation; and

WHEREAS, during review it was also discovered that while there is no parking is allowed on Goode Drive, Goode Drive is not specifically listed in said schedule; and

WHEREAS, the Board finds it in the best interest of the City to amend the Traffic Code to remove the local traffic only section and related schedule and add Goode Drive to the no through traffic schedule and the no parking at any time schedule.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF FENTON, MISSOURI, AS FOLLOWS:

- <u>Section 1</u>. Section 340.290, Vehicles Prohibited From Using Streets Designated For Local Traffic Only, of Title III, Traffic Code, of the Fenton Municipal Code is hereby repealed in its entirety.
- <u>Section 2</u>. Schedule XVII, Local Traffic Only, of Title III, Traffic Code, of the Fenton Municipal Code is hereby repealed in its entirety.
- <u>Section 3</u>. Schedule VIII, No Parking At Any Time, of Title III, Traffic Code, of the Fenton Municipal Code is hereby amended by adding to Table VIII-A of Schedule VIII the following:

Goode Drive

<u>Section 4.</u> Schedule XVIII, Regulation of Through Traffic, of Title III, Traffic Code, of the Fenton Municipal Code is hereby amended by adding to Table XVIII-A of Schedule XVIII the following:

Goode Drive

No through traffic between Larkin Willams Road and Church Street.

<u>Section 5</u>. This Ordinance shall be in full force and effect from and after the date of its passage and approval.
