LOCAL LAW NO. 2 OF THE YEAR 2019

A LOCAL LAW TO CHANGE THE DESIGNATION OF ONE CURRENTLY UNCONTROLLED INTERSECTION TO A YIELD INTERSECTION.

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF FISHKILL AS FOLLOWS:

Section 1.

Findings and Purpose

1.1. The Town Board of the Town of Fishkill does hereby make the following findings and does hereby declare the following purposes with regard to the enactment of this local law:

- ⇒ The Ward Place and Mountain View Road intersection is not currently designated within Chapter 143 of the Fishkill Town Code and is operating as an uncontrolled intersection. Traffic volume at this intersection suggests that designation and operation of this intersection as a Yield intersection would be more appropriate.

- ⇒ From the foregoing finding, it is the determination of the Town Board that there is a need to list and designate the intersection noted above as a Yield Intersection designation in Schedule "B" of Chapter 143 of Fishkill Town Code.

Section 2.

Town Code Amendments

2.1. Section 143–17 of the Town of Fishkill Code shall be repealed and replaced with a new Section 143–17 to read as follows:

LOCAL LAW NO. 2 OF THE YEAR 2019

§ 143-17. Designation of yield intersections.

The intersections referenced on Schedule B, dated June 19, 2019, and annexed hereto and incorporated herein, as possessing yield signs are all hereby designated yield intersections to be henceforth controlled by the yield signs situated at such intersections as of the effective date of this article.

2.2. Schedule “B” incorporated into Chapter 143 of the Town of Fishkill Code is hereby modified to read as follows:

Section 3.

SEQRA

3.1. Enactment of this local law constitutes a Type II action in that it consists of the adoption of regulations, policies, procedures and local legislative decisions in connection with the installation of traffic control devices on existing streets, road and highways within the meaning of 6 NYCRR Section 617.5 (c)(22).

Section 4.

Severability

4.1. The invalidity or unenforceability of any particular provision of this local law shall not affect the validity or enforceability of other provisions of this local law, which such provisions shall continue to be both enforceable and valid.

Section 5.

Effective Date

5.1. This local law shall take effect upon the filing of certified copies thereof with the Office of the Secretary of State in accordance with the Municipal Home Rule Law.
