ARTICLE 1: ENACTMENT, AUTHORIZATION, TITLE, PURPOSE

Section 101: Enactment and Authorization

The Village of Geneseo Board of Trustees does hereby ordain and enact the Village of Geneseo moratorium on inns requiring new special use permits within all Zoning Districts in the Village of Geneseo pursuant to authority and provisions of Section 10 of the Municipal Home Rule Law.

Section 102: Title

This local law shall be known as the Village of Geneseo moratorium on inns requiring new special use permits within all zoning districts in the Village of Geneseo.

Section 103: Purpose

a) It is the purpose of this local law to protect the public interest for the Village of Geneseo to designate certain areas within the confines of the Village of Geneseo as zones generally for commercial and/or residential purposes.
b) It is the further purposed of this local law to allow time for the Village of Geneseo Board of Trustees to clarify the term " transients " as used in the definition of " Inns " pursuant to the Village of Geneseo Code Section 130-5. ARTICLE II: IMPOSTION OF MORATORIUM

Section 201: Imposition of Moratorium

For a period of six months after the date of filing this local law with the Department of State, no street level space or location within the Village of Geneseo shall be utilized in any manner as an inn if it requires new special use permits. For purposes of this local law, the term " inn " is defined in the Village of Geneseo Code Section 130-5 as follows:

"A commercial facility for the housing and feeding of transients, containing more than five rooms and less than 35 rooms. The facility may have an ancillary use such as a restaurant or bar." This local law is applicable to the prohibited use of space from the date of the proposed local law on the Village of Geneseo regular monthly meeting agenda.

ARTICLE III: VALIDITY

Section 301: Validity

If any section, sentence, clause, or phrase of this local law is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this local law.

ARTICLE IV: EXPIRATION

Section 401: Expiration

This six (6) month moratorium, unless otherwise extended by the Village Board of Trustees shall expire upon (a) the enactment of a local amending the current definition of "inns" by defining the word "transients" as found in said definition; (b) the adoption by the Village of Geneseo Board of Trustees of a resolution expressing said Board's determination that the further regulation would not be appropriate: or (c) the elapse of six months from the effective date of this local law, whichever shall first occur. ARTICLE V: EFFECTIVE DATE

Section 501: Effective Date

This Local Law shall take effect immediately after filing with the Secretary of State.
