ORDINANCE # 24 - 02

AN ORDINANCE AMENDING CHAPTER 445, VEHICLES AND TRAFFIC BY ADDING A NEW SECTION TO BE ENTITLED "PARKING ON LIBRARY MUNICIPAL PARKING LOT" TO BE LOCATED AT 58 N. MAIN STREET

BE IT ORDAINED by the Mayor and Council of the Borough of Glassboro, County of Gloucester and State of New Jersey that Chapter 445, Vehicles and Traffic, is hereby amended as follows:

Section 1. There is hereby established a Library Municipal Parking Lot for Library Patrons Only for property located at 58 N. Main Street.

Section 2. Parking by Library Patrons Only at the Library Municipal Parking Lot shall be permitted between the hours of 7:00 a.m. to 10:00 p.m., Monday through Saturday.

Section 3. Parking shall be prohibited at the Library Municipal Parking Lot between the hours of 10:00 p.m. to 7:00 a.m., Monday through Saturday and all day Sunday.

Section 4. Enforcement

This section shall be enforced by the Police Department, Parking Enforcement Officers, Code Enforcement Officers and/or other municipal officials of the Borough of Glassboro.

Section 5. Penalties

Any person who violates any provision of this section shall, upon conviction thereof, be punished by a fine of not less than \$50.00 but not more than \$1,000 or by community service or by imprisonment for a term, not exceeding 90 days, or a combination of all three.

Section 6. Repealer

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

Section 7. Severability

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law.
