1. PURPOSE

The Village Board of Trustees intends to do everything reasonable and responsible to keep from raising the tax burdens on Village residents. Notwithstanding this, as a matter of fiscal prudence and in order to provide the Village with the services its residents need, the Village Board of Trustees requires sufficient flexibility in the budgeting process to enable it to raise adequate revenues to operate the Village in a safe and responsible manner. This is especially true during this period when many Village expenses have increased during the high inflation of the past year. It is therefore the intent and purpose of this local law to allow the Village to adopt a budget for the upcoming fiscal year that may require a real property tax levy in excess of the "tax levy limit" as defined in New York State's General Municipal Law Section 3-c.

II. AUTHORITY

This local law is adopted pursuant to subdivision 5 of General Municipal Law Section 3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

III. AMENDMENT

Article VII of Chapter 191 of the Village Code is hereby amended by adding thereto a Section 191-41 which shall state as follows:

"Section 191-41. Override Authority For Fiscal Year Commencing March 1, 2024

The Village Board of Trustees is hereby authorized to adopt a budget for the fiscal year commencing March 1, 2024 that requires a real property tax levy in excess of the amount otherwise prescribed in New York State's General Municipal Law Section 3-c."

IV. SEVERABILITY

The invalidity of any sentence, part or provision of this local law shall not affect the validity of any other part of the Local Law which can be given effect without such invalid part of parts.

V. EFFECTIVE DATE

This local law shall become effective immediately as provided in the Municipal Home Rule Law upon being filed in the Office of the Secretary of State.
