Local Law No. 3 of the year 2024

A local law repealing Section 191-41 of the Village Code which authorized an override of the tax levy limit established in New York State's General Municipal Law Section 3-c for the fiscal year commencing March 1, 2024.

Be it enacted by the Board of Trustees of the

County City Town Village
of Great Neck Plaza as follows:

1. PURPOSE

The Village Board of Trustees previously enacted Local Law 1 of 2024 to give it flexibility in the budgeting process by allowing an override for the fiscal year commencing March 1, 2024 of the "tax levy limit" as defined in New York's General Municipal Law Sec 3-c. Since then, the Village has completed its budget for the fiscal year commencing March 1, 2024, and it was not necessary to override the tax levy limit. The Village Board of Trustees now therefore determines that it will serve the health, benefit and welfare of the Village and its residents to repeal the provision of the Village Code authorizing said override.

II. AMENDMENT

Section 191-41 of the Village Code, which authorized, for the fiscal year commencing on March 1, 2024, an override of the tax levy limit in excess of the amount otherwise prescribed by General Municipal Law Section 3-c, is hereby repealed.

IV. SEVERABILITY

The invalidity of any sentence, part or provision of this local law shall not affect the validity of any other part of the Local Law which can be given effect without such invalid part of parts.

V. EFFECTIVE DATE

This local law shall become effective immediately as provided in the Municipal Home Rule Law upon being filed in the Office of the Secretary of State.
