

ORDINANCE NO. 2337-24

AN ORDINANCE TO FURTHER AMEND AND SUPPLEMENT CHAPTER 505 OF THE CODE OF THE BOROUGH OF HAWTHORNE VEHICLES AND TRAFFIC, ARTICLE II, TRAFFIC REGULATIONS, SECTION 505-5 SPEED LIMITS, SCHEDULE II, SO AS TO AMEND THE SPEED LIMIT FOR GRANDVIEW AVENUE, THE LOWER PORTION OF WATCHUNG DRIVE AND NORTH WATCHUNG DRIVE

BE IT ORDAINED by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Chapter 505, Vehicles and Traffic, Schedule II, Section 505-54 Speed Limits, is amended so as to amend the established speed limit on Rea Avenue Extension as follows:

Sec. 505-54, Schedule II: Speed Limits

In accordance with the provisions of Section 505-5, speed limits are hereby established upon the following described streets or parts thereof:

<u>Name of Street</u>	<u>Speed Limit (mph)</u>	<u>Location</u>
Grandview Avenue	25	Entire Length
Watchung Drive	25	From N. Watchung to Goffle Road
North Watchung Drive	25	Entire Length

Section 2. All parts and provisions of Section 505 not specifically affected by the above amendments and modifications shall remain in full force and effect.

Section 3. This Ordinance shall take effect after final adoption and publication as provided by law.
