Article II – Commercial Property

§ 362-5 Policy; purpose of article

 \S $362\text{-}10\,$ Abatement of violations regarding grass, weeds, brush or other debris; recovery of costs by Township.

If the owner, tenant or person in possession of the lands served notice pursuant to this article shall refuse or neglect to abate or remedy the violation regarding grass, weeds, brush or other debris set forth in the notice within [10] five (5) days after receipt of notice, the enforcement officer shall cause the condition complained of to be abated and remedied by the Department of Public Works, which shall certify the cost thereof to the Department of Finance, which shall cause the cost as shown thereon to be charged against the lands. The amount so charged shall forthwith become and form a part of the taxes next to be assessed and levied upon such lands and shall bear interest at the same rate as taxes, and shall be collected and enforced by the same officer and in the same manner as taxes. Costs shall be in addition to any penalties imposed for any violation of this article.
