- WHEREAS, on February 16, 2010, the County Council enacted Bill 10-02, which increased the boundaries to within 1,000 feet of a refuse disposal system; and
- WHEREAS, 36 applications were submitted and reviewed for compliance with the provisions of these Bills; and
- WHEREAS, it was determined that these 36 properties meet the parameters of Bill Nos. 92-89 and 10-02.
