ORDINANCE NO. 35-2023

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER AMENDING AND SUPPLEMENTING SECTION 267-42. ENTITLED "SCHEDULE XII: TRUCKS OVER CERTAIN WEIGHTS EXCLUDED" UNDER CHAPTER 267 OF THE CODE OF THE TOWNSHIP OF HANOVER ENTITLED VEHICLES AND TRAFFIC WITH THE INCLUSION OF TROY ROAD IN THE WHIPPANY SECTION OF THE TOWNSHIP FROM TROY HILLS ROAD TO THE HANOVER TOWNSHIP – EAST HANOVER TOWNSHIP CORPORATE LINE

WHEREAS, due to the anticipated increase in the volume of truck traffic on Troy Road, a residential street in the Whippany Section of the Township, it is the intention of the Township Committee to exclude vehicles in excess of the gross weight limit of four (4) tons from traveling Troy Road from Troy Hills Road to the Hanover Township—East Hanover Township corporate line.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

<u>Section 1.</u> Section 267-42. Schedule XII: Trucks Over Certain Weights Excluded. Under Chapter 267 of the Code of the Township of Hanover entitled <u>Vehicles in Traffic.</u> is hereby amended and supplemented as follows:

"In accordance with the provisions of Section 267-15, trucks in excess of the gross weights indicated are hereby excluded from the following streets or parts of streets, except for the pick-up and delivery of materials on such streets:

Section 2. This Ordinance shall be enforced by the Police Department.

<u>Section 3.</u> The violations and penalties provisions of Section 267-3. under Chapter 267 of the Code of the Township of Hanover shall apply unless another penalty is expressly provided by Title 39 of the New Jersey State Statutes.

<u>Section 4.</u> In case, for any reason, any section or provision of this Ordinance shall be held to be unconstitutional or invalid, the same shall not affect any other section or provision of this Ordinance, except so far as the section or provision so declared unconstitutional or invalid shall be severed from the remainder or any portion thereof.

<u>Section 5.</u> All ordinances or parts of ordinances inconsistent with the provision of this Ordinance and Chapter 267 of the Code of the Township, are to the extent of such inconsistency, hereby repealed.

Section 6. This Ordinance shall take effect in accordance with law.
