ORDINANCE NO. 3-2024

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER AMENDING AND SUPPLEMENTING SECTION 125-4. ENTITLED "RECREATION DEPARTMENT FEES" UNDER CHAPTER 125 OF THE CODE OF THE TOWNSHIP ENTITLED FEES WITH THE INCLUSION OF NEW 2024 FEES RELATED TO VARIOUS RECREATION AND PARK ADMINISTRATION DEPARTMENT PROGRAMS AND ACTIVITIES AND THE INCLUSION OF NEW RESIDENT AND NON-RESIDENT POOL MEMBERSHIP FEES FOR THE YEAR 2024 BEE MEADOW SWIMMING POOL SEASON

WHEREAS, the Board of Recreation Commissioners, during its January 23, 2024 regular meeting, approved a new 2024 fee schedule for various programs and activities sponsored by the Township's Recreation and Park Administration Department and the new 2024 Bee Meadow Swimming Pool season membership fees; and

WHEREAS, in memoranda dated January 24, 2024 to the Mayor and Township Committee, the Superintendent of the Recreation and Park Administration Department, in accordance with the recommendations of the Board of Recreation Commissioners, submitted a list of the revised program fees for various fall, winter and spring programs including other events sponsored by the Department and the new 2024 pool membership fees; and

WHEREAS, in memoranda dated January 24, 2024 to the Mayor and Township Committee, the Superintendent of the Recreation and Park Administration Department, in accordance with the recommendations of the Board of Recreation Commissioners, submitted a list of the revised field permit fees, Community Center fees and Proctor fees for calendar year 2024; and

WHEREAS, the three memoranda of the Superintendent of the Recreation and Park Administration Department dated January 24, 2024, are incorporated herein and made a part of this Ordinance as if set forth in full.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the

<u>Section 3.</u> In case, for any reason, any section or provision of this Ordinance shall be held to be unconstitutional or invalid, the same shall not affect any other section or provision of this Ordinance, except so far as the section or provision so declared unconstitutional or invalid shall be severed from the remainder or any portion thereof.

Section 4. All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are, to the extent of such inconsistency, hereby repealed.

Section 5. This ordinance shall take effect in accordance with the law.
