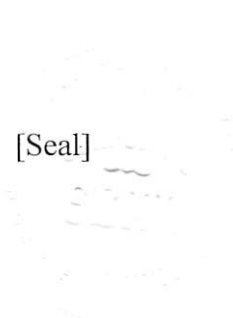

**A RESOLUTION AUTHORIZING A PUBLIC QUESTION TO BE SUBMITTED TO
THE VOTERS OF THE VILLAGE OF HOMER GLEN**

WHEREAS, Pursuant to the Illinois Election Code, 10 ILCS 5/28-1 et seq., and the Illinois Municipal Code, 65 ILCS 5/1-1-8, the corporate authorities of a municipality have the authority to submit a public question to the electors of the municipality by means of a referendum; and

WHEREAS, The Board of Trustees hereby intends to submit to the residents of the Village of Homer Glen a public question of village-wide significance; and

WHEREAS, The Board of Trustees believes it is in the best interest of the residents of the Village of Homer Glen to move expeditiously as possible to submit this proposition to the voters at the next regularly scheduled election, to be held on March 19, 2024; now, therefore,

NOW, THEREFORE, BE IT RESOLVED by the Village President and Village Board of Trustees of the Village of Homer Glen, Will County, Illinois, by and through its Home Rule Powers, as follows:

Section 1. The above recitals are expressly incorporated herein and made part hereof as though fully set forth herein.

Section 2. The Board of Trustees of the Village of Homer Glen does hereby initiate and authorize the following public question to be submitted to the voters of the entire Village of Homer Glen at the regularly scheduled election next occurring after the effective date of this resolution, on March 19, 2024:

Should the Village of Homer Glen take appropriate action and pursue appropriate efforts to potentially dissolve or discontinue township government?

Section 3. The Village Clerk of the Village of Homer Glen shall certify the public question referenced herein to the Will County Clerk in accordance with Article 28 of the Election Code.

Section 4. This resolution shall be in full force and effect upon its passage.
