## AN ORDINANCE AMENDING SECTION 700.080 SEWER RATES OF THE CODE OF THE CITY OF HOLLISTER, MISSOURI.

## BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HOLLISTER, MISSOURI AS FOLLOWS:

## Section 700.080 Sewer Rates.

A. Residential and commercial sewer user service charge inside City limits nine dollars and twenty-seven cents (\$9.55) per month.

Use charges:

\$3.78 for the first 1,000 gallons

\$0.378 per 100 gallons additional

B. Residential and commercial sewer user service charge outside City limits eleven dollars and eighty-five cents (\$12.21) per month.

Use charges:

\$5.67 for the first 1,000 gallons

\$0.567 per 100 gallons additional

C. *Residential And Commercial Extra Charges*. The extra charge for biochemical oxygen demand and suspended solids shall be:

1. For five (5) day biochemical oxygen demand in excess of two hundred fifty (250) milligrams per liter of sewage and waste, an additional charge of \$0.479 per pound shall be made by each such excess or fraction thereof.

2. For suspended solids in excess of three hundred (300) milligrams per liter of sewage and waste, an additional charge of \$0.426 per pound shall be made for each such excess or fraction thereof.

D. Non-Metered Sewer Rates (City Water Not Available).

1. For residential contributors inside City limits, the minimum monthly flat rate (5,000-gallon average) for the collection and treatment of sewerage shall be as follows:

2. For residential contributors outside City limits, the minimum monthly flat rate (5,000-gallon average) for the collection and treatment of sewerage shall be as follows:

Unit Cost/Month

Residential \$40.53

E. Sewer Flow Meter (City Water Not Available). To qualify for the metered rate, the contributor must be non-residential and shall have a City approved meter (contributor shall purchase, install and maintain meter on their well unless there is already an installed meter from a water district) and approved meter reading method (location).

1. Commercial sewer user service charge inside City limits nine dollars and twenty-seven cents (\$9.55) per month.

\$3.78 for the first 1,000 gallons

\$0.378 per 100 gallons additional

2. Commercial sewer user service charge outside City limits eleven dollars eighty-five cents (\$12.21) per month.

Use charges:

\$5.67 for the first 1,000 gallons

\$0.567 per 100 gallons additional

\$3.54 per 1,000 gallons

G. Hauled Waste Sewer Charges.

2. Septic Tank

Use charges:

\$18.89 per 1,000 gallons
