

AN ORDINANCE AMENDING SECTION 605.130, B. AMOUNT OF LICENSE FEE OF THE CODE OF THE CITY OF HOLLISTER, MISSOURI.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HOLLISTER, MISSOURI AS FOLLOWS:

SECTION 605.130: AMOUNT OF LICENSE FEE

B. The charge for the license is based on the average number of employees employed by the business during the preceding year. For computation purposes, two (2) part-time employees shall equal one (1) employee.

0--2 employees	\$ 20.00
3--5 employees	40.00
6--10 employees	60.00
11--15 employees	80.00
16--20 employees	100.00
21--30 employees	120.00
31 or more employees	150.00

1. In addition to the above listed fee there shall be a twenty-five dollar (\$25.00) Administrative Fee charged each year.
2. Each year a forty-five dollar (\$45.00) fire inspection fee will be applied. The City of Hollister and Western Taney County Fire will perform one (1) time per year, a courtesy reinspection at no cost to the owner.
3. Reinspection fee after courtesy inspection: twenty dollar (\$20.00).

SECTION 605.130: AMOUNT OF LICENSE ~~TAX~~**FEE**

A. It shall be unlawful for any person to exercise, carry on, or engage in any of the following occupations, professions, trades, businesses or agencies in the City of Hollister, Missouri, without having obtained a license therefor, as hereinafter provided, and the charge for such license shall be respectively as follows, to wit:

2. Each year a forty-five dollar (\$45.00) fire inspection fee will be applied. The City of Hollister and Western Taney County Fire will perform one (1) time per year, a courtesy reinspection at no cost to the owner.

C. Any business owner that has not renewed their license by August first (1st) shall be charged an additional ten dollar (\$10.00) penalty.
