BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HOLLISTER, MISSOURI AS FOLLOWS:

A verified petition requesting voluntary annexation and signed by the owners, Wade Acquisition Series B LLC, of all fee interests of record in all tracks of real property located within the areas described below, which are proposed to be annexed within the City of Hollister has been presented to the Hollister Board of Aldermen. Subsequent to receiving said petition the Hollister Board of Aldermen conducted a public hearing on the 21st day of December, 2023 at 7:00 P.M. concerning the matter in accordance with the provisions of Section 71.012 of the Revised Statutes of Missouri.
