## ORDINANCE NO.: 2023-06

## AN ORDINANCE OF THE BOROUGH OF HUMMELSTOWN AMENDING CHAPTER 15 (MOTOR VEHICLES), PART 2 (TRAFFIC REGULATIONS), SECTION 15-207 (USE OF SKATEBOARDS PROHIBITED), TO AMEND THE DEFINITION OF SKATEBOARD.

WHEREAS, the Borough Council of Hummelstown Borough, Dauphin County, Pennsylvania is vested with the legislative authority to adopt ordinances to secure the safety of persons and property within its borders. *See* 8 Pa.C.S. § 1202; *and* 

**WHEREAS**, pursuant to the authority set forth by the Pennsylvania Vehicle Code, 75 P.S. § 101 *et seq.*, and specifically in Section 6102 thereof, Borough Council hereby adopts a definition of skateboard in furtherance of the health, safety, and welfare of Hummelstown residents; *and* 

WHEREAS, the Borough Council, after due consideration of the proposed ordinance amendment at a duly advertised public meeting, has determined that the health, safety, and general welfare of the residents of the Borough of Hummelstown will be served by the proposed amendments.

**NOW, THEREFORE, IT IS HEREBY ORDAINED AND ENACTED**, by the authority of the Borough Council of the Borough of Hummelstown, Dauphin County, Pennsylvania, that the Code of Ordinances of Hummelstown Borough, Chapter 15 (Motor Vehicles), Part 2 (Traffic Regulations), Section 15-207 is amended as follows with bracketed and struck text to be deleted, underlined text to be added, and ellipses to show sections of code remaining unchanged:

### **SECTION 1: ORDINANCE AMENDMENT.**

Section 15-207 Use of Skateboards Prohibited.

1. No person shall ride or otherwise be transported upon a skateboard or similar vehicle on [skates and propelled solely by human power upon any highway, as that term is defined in the Pennsylvania Vehicle Code, Act of June 17, 1976, P.L. 162, No. 81, § 1, or any amendments thereto now in force or hereinafter enacted.] one or more wheels, on which the rider stands, regardless of how the device is powered or propelled upon any highway.

**SECTION 2. SEVERABILITY.** If any section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase or word in this Ordinance is declared by any reason to be illegal, unconstitutional or invalid by any court of competent jurisdiction, such decision shall

not affect or impair the validity of this Ordinance or Chapter 15 of Hummelstown Borough Code of Ordinances as a whole, or any other section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase, word or remaining portion of this Ordinance or Chapter of the Borough Code. The Borough Council hereby declares that it would have adopted this Ordinance and each section, subsection, phrase and word thereof, irrespective of the fact that any one or more of those sections, subsections, provisions, regulations, limitations, restrictions, sentences, clauses, phrases or words may be declared illegal, unconstitutional or invalid.

**SECTION 3. REPEALER.** All ordinances or parts of ordinances that are inconsistent herewith shall be and the same expressly are repealed.

**SECTION 4. EFFECTIVE DATE.** This Ordinance shall become effective in accordance with applicable law.

**BE IT DULY ORDAINED AND ENACTED** into law this <u>17</u> day of <u>August</u>, 2023, by Hummelstown Borough, Dauphin County, Pennsylvania, in lawful session duly assembled.

The Borough Council of the Borough of Hummelstown, Dauphin County, Pennsylvania will hold a public meeting on August 17, 2023, at 7:00 p.m. at the Borough Municipal Building, 261 Quarry Road, Hummelstown, PA 17036, at which meeting the Borough Council will consider the enactment of a proposed ordinance amending Chapter 15 (Motor Vehicles), Part 2 (Traffic Regulations), Section 15-207 (Use of Skateboards Prohibited). The title and summary of the proposed ordinance are as follows:

#### AN ORDINANCE OF THE BOROUGH OF HUMMELSTOWN AMENDING CHAPTER 15 (MOTOR VEHICLES), PART 2 (TRAFFIC REGULATIONS), SECTION 15-207 (USE OF SKATEBOARDS PROHIBITED), TO AMEND THE DEFINITION OF SKATEBOARD.

<u>Section 1</u> Amends Section 15-207 (Use of Skateboards Prohibited) to update the definition of a regulated propellant.

<u>Section 2</u> is a severability section providing that if any provision of the proposed Ordinance is invalid, the remaining provisions shall remain in full force and effect. Section 3 repeals all prior ordinances or parts thereof that are inconsistent with the proposed Ordinance. Section 4 provides that the proposed Ordinance shall become effective in accordance with applicable law.

The full text of the proposed amendatory ordinance is on file for inspection and review without charge (or a copy may be obtained for a charge not greater than the cost thereof) at the Hummelstown Borough Municipal Building, 261 Quarry Road, Hummelstown, PA 17036.
