WHEREAS, the Town of Huntington, Division of Purchasing desires to amend the Purchasing policies to consider Best Value Purchasing Methodology; and

WHEREAS, New York State General Municipal Law Section 103 permits the purchase of goods and services utilizing Best Value Purchasing Methodology, including purchasing from cooperatives; and

WHEREAS, pursuant to 6 NYCRR section 617.5(c)(26) adopting regulations amending the code is a Type II action and no further SEQRA review is required at this time.

NOW, THEREFORE,

THE TOWN BOARD, having held a public hearing on the 6th day of February, 2024 at 7:00 p.m. to consider adopting Local Law Introductory No. 1-2024 amending the Code of The Town of Huntington Chapter 6 (Audit and Control, Department of), and due deliberation having been had,

HEREBY ADOPTS

Local Law Introductory No. 1-2024 amending the Code of the Town of Huntington, Chapter 6 (Audit and Control, Department of), as follows:

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF HUNTINGTON AS FOLLOWS:

CHAPTER 6

AUDIT AND CONTROL, DEPARTMENT OF

§ 6-4 Powers and duties.

*

The powers and duties of such Division therein shall be under the administration, direction and control of the Director, and each of the Divisions shall be supervised by a Division head who shall be designated as Division Administrator. The powers and duties of individual Divisions shall be: B. Division of Purchasing. This Division shall perform the following functions:

(5) The Director of the Purchasing Division shall be authorized to use Best Value Award Methodology for purchase contracts, for service work including contracts, but excluding contracts necessary for the completion of a public works contract pursuant to Article 8 of the New York Labor Law. The Best Value Award Methodology shall include the ability to purchase from cooperatives.

Section 2. Severability

*

If any clause, sentence, paragraph, subdivision, section or other part of this local law shall for any reason be adjudged by any court of competent jurisdiction to be unconstitutional or otherwise invalid, such judgment shall not affect, impair, or invalidate the remainder of this local law, and it shall be construed to have been the legislative intent to enact this local law without such unconstitutional or invalid parts therein.

Section 3. Effective Date

This Local Law shall take effect immediately upon filing in the Offices of the Secretary of State of New York.
