A local law TO AMEND THE CHARTER, AS AMENDED, OF THE

**MISCELLANEOUS
& STATE RECORDS**

ILION ARTICLE II, §C-3.D.E. AND ARTICLE II, §C-4.B

Be it enacted by the BOARD OF TRUSTEES of the

ARTICLE II, §C-3.D.E.-DELETE CURRENT LANGUAGE AND INSERT THE FOLLOWING -

D. 7 COMMISSIONERS WHO SHALL CONSTITUTE THE MUNICIPAL UTILITIES BOARD OF SAID VILLAGE -
SECTIONS F-G-H-I WILL BE RELETTERED EFGH
ARTICLE II, §C-4.B

THE WATER COMMISSIONERS AND THE LIGHT COMMISSIONERS OF THE VILLAGE OF ILION HENCEFORTH WILL BE KNOWN AS THE MUNICIPAL UTILITIES BOARD (MUB). THIS BOARD SHALL CONSIST OF SEVEN (7) MEMBERS APPOINTED BY THE VILLAGE BOARD FOR THE TERM OF FIVE (5) YEARS AND SERVE AS COMMISSIONERS AT THE PLEASURE OF THE BOARD OF TRUSTEES UNTIL THEIR SUCCESSORS HAVE BEEN APPOINTED AND HAVE QUALIFIED. COMMISSIONERS MAY BE REAPPOINTED TO A FIVE (5) YEAR TERM AT THE DISCRETION OF THE VILLAGE BOARD.

THE MUNICIPAL UTILITIES BOARD SHALL ELECT ONE OF ITS MEMBERS CHAIRPERSON AND MAY APPOINT A RECORDER/CLERK. THE MUNICIPAL UTILITIES BOARD SHALL OVERSEE THE OPERATION OF THE LIGHT DEPARTMENT, THE WATER DEPARTMENT AND DEPARTMENT OF PUBLIC WORKS. THE PRIMARY ROLE OF THIS BOARD (MUB) WILL BE TO OVERSEE THE OPERATION OF THESE DEPARTMENTS WORKING WITH THE VILLAGE ENGINEER, RESPECTIVE DEPARTMENT HEADS AND SUPERVISORS TO ENSURE MAXIMUM EFFICIENCY. THE BOARD (MUB) WILL MEET EACH MONTH WITH THE VILLAGE ENGINEER, DEPARTMENT HEADS AND SUPERVISORS ALONG WITH ONE (1) VILLAGE BOARD LIAISON MEMBER AND THE VILLAGE CLERK-TREASURER TO CONDUCT BUSINESS. THE BOARD (MUB) WILL PRESENT

THEIR RECOMMENDATIONS ON ALL MATTERS CONCERNED WITH THESE DEPARTMENTS INCLUDING THEIR BUSINESS OPERATIONS INVOLVING HIRING PERSONNEL, THEIR ASSIGNMENTS, SALARIES AND BENEFITS, RATES AND BILLING, PURCHASING EQUIPMENT AND SUPPLIES, TO THE VILLAGE BOARD FOR FINAL APPROVAL.

ALL MONEY DERIVED FROM THESE DEPARTMENT BUSINESS OPERATIONS SHALL BE PAID TO THE VILLAGE CLERK-TREASURER AND SHALL BE MAINTAINED IN SEPARATE FUNDS FOR DISBURSEMENT BY THE VILLAGE CLERK-TREASURER ON THE RECOMMENDATION OF THE MUNICIPAL UTILITIES BOARD WITH FINAL APPROVAL BY THE VILLAGE BOARD.


