Amending Section 450-8

Terms, fees and renewal

- A. All permits issued are valid for a period of one year
- B. All permits newly issued at any time during the calendar year shall terminate on December 31 of that same year.
- C. All new permits and renewal permit fees are due by January 1 of each calendar year.
- D. Late Fee:
 - a. If the permits are not paid for by February 15 of the calendar year: a late fee of \$50.00 will be added to the rental permit fee.
 - For each month that the rental permit fee is not paid; an additional \$50.00 a month (assessed at the 15th of each month) will be added to the rental permit fee.
- E. The Clerk of the Village is hereby authorized to pro-rate the fee for such permits according to the date on which such permits are issued. The amount of the pro-rated fee shall be determined by the Clerk of the Village.
- F. The rental fee for any permit will be set from time to time by the Board of Trustees.
