ORDINANCE #10-21

AN ORDINANCE AMENDING ORDINANCE #02-21 RELATING TO THE ESTABLISHMENT OF SALARY AND COMPENSATION LIMITS FOR CERTAIN OFFICES, POSITIONS AND EMPLOYEES IN THE BOROUGH OF JAMESBURG, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY.

WHEREAS, the Borough Council previously adopted Ordinance #02-21 on February 17, 2021, which established limits for salary and compensation of certain offices, positions and employees in the Borough of Jamesburg, County of Middlesex and State of New Jersey; and

WHEREAS, due to certain vacancies which have occurred relating to certain positions, it is necessary for the Borough Council to amend Ordinance #02-21 in order to revise the salary limits relating to the positions of Business Administrator, Chief Financial Officer, and Qualified Purchasing Official, as set forth below.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Jamesburg, in the County of Middlesex and State of New Jersey, that Ordinance #02-21, as adopted on February 17, 2021, is hereby amended and revised in the following limited respects (additions are shown with underline; deletions are shown with strikeout):
