MEMORANDUM

RE: AN ORDINANCE ORDERING AN ELECTION TO BE HELD ON TUESDAY, APRIL 2, 2024, UPON THE QUESTION OF DISINCORPORATION OF THE VILLAGE OF PEACEFUL VILLAGE AND FOR THE NOTICE OF THE ELECTION TO BE PUBLISHED IN ACCORDANCE WITH 80.570 RSMO.

Currently assigned Ordinance Number "23-0551"

DATE: 1/30/2024

ISSUE:

Your Office brought to the attention of the County Counselor an issue involving the apparent assignment of the same number to two different Ordinances, both of which were approved by the County Council and signed into law by the County Executive. Specifically, you brought to our attention that an Ordinance, which began as Bill 23-1248 (ordering an election to be held on the disincorporation of Village of Peaceful Village, and referenced above), and an Ordinance which began as Bill 23-1135, A1 (approving the budget for fiscal year 2024) had both been assigned Ordinance Number "23-0551."

ANALYSIS:

This Office has reviewed the journals of the relevant County Council Meetings and determined that the assignment of "23-0551" to the Ordinance relating to the budget (i.e. what was Bill 23-1135, A1) is correct. The assignment of "23-0551" to the Ordinance relating to the election on the disincorporation of the Village of Peaceful Village (i.e., what was Bill 23-1248 and referenced above) is incorrect. That number had already been assigned to the budget Ordinance. Moreover,

the Village of Peaceful Village Ordinance was enacted in calendar year 2024, being signed into law by County Executive Gannon on January 16, 2024. It should, therefore, never have been assigned a "23" Ordinance number, but should, instead, have been assigned a "24" Ordinance number.

We note that the other Ordinances that were passed at the January 8, 2024, County Council Meeting, and signed into law by the Executive (also on January 16, 2024), were assigned Ordinance numbers 24-0100 through 24-0106. The Village of Peaceful Village Ordinance should have been assigned the next number in line, i.e., 24-0107.

Further, regarding this Ordinance we note that, on page 4, staff inadvertently left off the date for the Third Reading. The Journal of the January 8, 2024, County Council Meeting reflects that such reading occurred at the January 8, 2024, Meeting.

CONCLUSION:

Therefore, the Ordinance, which began as Bill 23-1248 and which was titled "AN ORDINANCE ORDERING AN ELECTION TO BE HELD ON TUESDAY, APRIL 2, 2024, UPON THE QUESTION OF DISINCORPORATION OF THE VILLAGE OF PEACEFUL VILLAGE AND FOR THE NOTICE OF THE ELECTION TO BE PUBLISHED IN ACCORDANCE WITH 80.570 RSMO[,]" is Ordinance Number 24-0107.

The fact that this Ordinance was originally assigned an already used number does not affect the validity of the Ordinance. It is Ordinance Number 24-0107.

This Office does not desire to alter or amend the Ordinance by interlineation or otherwise. Thus, we ask that you forever keep this Memorandum with the Ordinance, and that you correct County Clerk records to reflect that "24-0107" is the correct number for this Ordinance and that it be removed from electronic storage amongst the 2023 Ordinances and instead be electronically stored amongst the 2024 Ordinances.

Further, any Ballot References regarding the question of the disincorporation of the Village of Peaceful Village should be to "Ordinance Number 24-0107."




