5	EXECUTE THE AGREEMENT ON BEHALF OF THE COUNTY.
6	WHEREAS, Jefferson County, Missouri, (hereafter, the "County") desires to
7	renew the PowerDMS hosted subscription fee with PowerDMS for the Department of the
8	Sheriff; and
9	WHEREAS, the Department of the Sheriff desires to renew the PowerDMS hosted
10	subscription fee with for a one-year agreement; and
11	WHEREAS, the Department of the Sheriff requests to renew the agreement
12	provided by PowerDMS for the PowerDMS hosted subscription fee used by the Jefferson
13	County Sheriff's Office for department notifications, trainings, and polices; and
14	WHEREAS, the Department of the Sheriff requests the renewal of the PowerDMS
15	hosted subscription fee with PowerDMS for the department notifications, trainings, and
16	polices; and
17	WHEREAS the Department of the Sheriff desires that, the County renew the
18	PowerDMS hosted subscription fee with PowerDMS for the department notifications,
19	trainings, and polices for a one-year agreement; and

Jefferson County, Missouri Contract# <u>A-2962</u> WHEREAS, the Jefferson County, Missouri, Council finds that it is now necessary and in the best interest of the County to execute the renewal agreement for the PowerDMS hosted subscription fee with PowerDMS for the department notifications, trainings, and polices for a one (1) year PowerDMS hosted subscription fee, running from 2-26-2024 to 2-25-2025, for the total amount not to exceed \$9,769.83, subject to budgetary limitations.

6 BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL, 7 AS FOLLOWS:

8 <u>Section 1</u>. The renewal agreement with PowerDMS for the department 9 notifications, trainings, and polices for the PowerDMS hosted subscription fee for a one 10 (1) year PowerDMS hosted subscription fee, running from 2-26-2024 to 2-25-2025, for the 11 total amount not to exceed **\$9,769.83** is approved, subject to budgetary limitations.

12 <u>Section 2</u>. The Jefferson County, Missouri, Council hereby authorizes the 13 County Executive to execute the agreement on behalf of the County. The County 14 Executive is further authorized to take any and all actions necessary to carry out the intent 15 of this Ordinance. An unexecuted copy of the Agreement is attached hereto as Exhibit "A" 16 and incorporated herein, by reference.

17 Section 3. Copies of all Invitations for Bid, Requests for Proposals, responses
18 thereto, and any contracts or agreements shall be maintained by the Department of the
19 County Clerk consistent with the rules and procedures for the maintenance and retention
20 of records as promulgated by the Secretary of State.

<u>Section 4.</u> This Ordinance shall be in full force and effect from and after its
 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity
 shall not affect the remainder of this Ordinance.
