1 **AN ORDINANCE APPROVING A RENEWAL OF A SUBSCRIPTION**
2 **LICENSE MAINTENANCE AGREEMENT BETWEEN THE JEFFERSON**
3 **COUNTY, MISSOURI, DEPARTMENT OF THE SHERIFF AND THE**
4 **PROSECUTING ATTORNEY’S OFFICE, ON THE ONE HAND, AND VERIPIC,**
5 **INC., ON THE OTHER, AND AUTHORIZING THE COUNTY EXECUTIVE TO**
6 **EXECUTE THE AGREEMENT ON BEHALF OF THE COUNTY.**

7 **WHEREAS,** pursuant to Ordinance 18-0528 Jefferson County, Missouri (the
8 “County”) approved a Subscription License Maintenance Agreement with VeriPic, Inc.;
9 and

10 **WHEREAS,** pursuant to Ordinances 20-0121, 21-0108, 22-0114 and 22-0557
11 Jefferson County, Missouri (the “County”) approved the renewal Subscription License
12 Maintenance Agreement with VeriPic, Inc.; and

13 **WHEREAS,** the Subscription License Maintenance Agreement enabled the
14 County’s Department of the Sheriff and the Prosecuting Attorney’s Office to use certain
15 software offered and supported by VeriPic, Inc.; and

16 **WHEREAS,** the use of said software includes use by the Department of the
17 Sheriff’s Evidence Manager and the Prosecuting Attorney’s Office for photographing and
18 for video interviews; and

1 **WHEREAS**, the County’s Department of the Sheriff desires to renew the
2 Subscription License Maintenance Agreement with VeriPic, Inc., for continued
3 maintenance support services for an additional year; and

4 **WHEREAS**, the Prosecuting Attorney’s Office likewise desires that the
5 Subscription License Maintenance Agreement with VeriPic, Inc., be renewed for the
6 maintenance support services for an additional year; and

7 **WHEREAS**, Jefferson County, Missouri, Council finds that it is now necessary
8 and in the best interest of the County to execute the Subscription License Maintenance
9 Agreement Renewal with VeriPic, Inc., for the support and maintenance services for the
10 VeriPic software and licensing for a one (1) year starting 3-1-2024 and ending 2-28-2025,
11 for the total amount not to exceed **\$15,820.00**, subject to budgetary limitations.

12 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,**
13 **AS FOLLOWS:**

14 Section 1. The Subscription License Maintenance Agreement Renewal with
15 VeriPic, Inc., for the support and maintenance services for the VeriPic software and
16 licensing is approved for a one (1) year, starting 3-1-2024 and ending 2-28-2025, for the
17 total amount not to exceed **\$15,820.00**, subject to budgetary limitations.

18 Section 2. The Jefferson County, Missouri, Council hereby authorizes the
19 County Executive to execute the Subscription License Maintenance Agreement Renewal,
20 an unexecuted copy of which is attached hereto as Exhibit “A” and incorporated herein by
21 reference, on behalf of the County. The County Executive is further authorized to take any
22 and all actions necessary to carry out the intent of this Ordinance.

1 Section 3. Copies of any Invitations for Bid, Requests for Proposals, responses
2 thereto, and any contracts or agreements shall be maintained by the Department of the
3 County Clerk consistent with the rules and procedures for the maintenance and retention
4 of records as promulgated by the Secretary of State.

5 Section 4. This Ordinance shall be in full force and effect from and after its
6 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity
7 shall not affect the remainder of this Ordinance.



VeriPic may include new terms and conditions, changes in pricing or other changes with the normal correspondence, quotes or invoices without the need for using Certified or Registered mail.
