1	AN ORDINANCE TO AUTHORIZE THE COUNTY EXECUTIVE TO
2	EXECUTE CHANGE ORDER NO. 1 FOR THE FACILITY SERVICES
3	MAINTENANCE BUILDING 2023 CONTRACT FOR THE JEFFERSON COUNTY,
4	MISSOURI, DEPARTMENT OF PUBLIC WORKS.
5	WHEREAS, Pursuant to Ordinance 23-0416, Jefferson County, Missouri, and the
6	Department of Public Works entered into a Contract, known as the Facility Services
7	Maintenance Building 2023 Contract, with Boyer Building & Design, Inc. for \$888,794.00
8	for the term; and,
9	WHEREAS, the Department of Public Works of Jefferson County, Missouri finds
10	that it is now necessary to adjust the estimated amount of the Facility Services Maintenance
11	Building 2023 Contract; and
12	WHEREAS, Change Order No. 1 is needed to correct an error in the agreement that
13	states a ten percent (10%) retainage requirement when RSMO 8.960 only allows public
14	entities to retain a maximum of five percent (5%); Boyer Building & Design has requested
15	this change to comport with state law; and
16	WHEREAS, in addition the County needs to add the construction of the interior

- 17 concrete floor slab, this was going to be a part of Phase 2 project however, the County will
- 18 now be constructing that in-house; and

1 WHEREAS, Jefferson County, Missouri and the Department of Public Works, 2 Division of Fleet Services for Jefferson County, hereby request an increase of Eighty-Four 3 Thousand Nine Hundred and Twenty Dollars (\$84,920.00) to the Facility Services 4 Maintenance Building 2023 Contract with Boyer Building & Design, Inc.; and,

5 WHEREAS Jefferson County, Missouri, Council finds that it is now necessary and 6 in the best interest of the County to execute Change Order No. 1 to the Facility Services 7 Maintenance Building 2023 Contract with Boyer Building & Design, Inc., for an increase of 8 Eighty-Four Thousand Nine Hundred and Twenty Dollars (\$84,920.00) to the contract sum, 9 subject to budgetary limitations; for a revised total of Nine Hundred Seventy Three 10 Thousand, Seven Hundred and Fourteen Dollars (\$973,714.00) for the Facility Services 11 Maintenance Building 2023 Contract upon approval.

BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL, **AS FOLLOWS:**

12 The Contract with Boyer Building & Design, Inc., for Facility Section 1. Services Maintenance Building 2023 shall be amended in two ways, first, the Contract shall 13 14 be increased by Eighty-Four Thousand Nine Hundred and Twenty Dollars (\$84,920.00) for a 15 revised total cost of Nine Hundred Seventy Three Thousand, Seven Hundred and Fourteen 16 Dollars (\$973,714.00), subject to budgetary limitations, and, second, notwithstanding the provisions of Section 5.1.1 of the "Agreement Form" portion of the Contract, the Owner 17 18 (County) will require withholding of a five percent (5%) retainage.

19 Section 2. The Jefferson County, Missouri, Council hereby authorizes the County 20 Executive to execute Change Order No. 1 to the Facility Services Maintenance Building Page 2 of 5


2023 Contract with Boyer Building & Design, Inc., and any agreements or contracts
 necessary to effectuate the award of the bids and proposals set forth in this Ordinance. The
 County Executive is further authorized to take any and all actions necessary to carry out the
 intent of this Ordinance.

5 <u>Section 3.</u> Copies of all Invitations for Bid, response thereto, any contract 6 agreements and change orders shall be maintained by the Department of the County Clerk 7 consistent with the rules and procedures for the maintenance and retention of records as 8 promulgated by the Secretary of State.

9 Section 4. This Ordinance shall be in full force and effect from and after its date
10 of approval. If any part of this Ordinance is invalid for any reason, such invalidity shall not
11 affect the remainder of this Ordinance.
