5	WHEREAS, Pursuant to Ordinance 23-0250 Jefferson County, Missouri and the
6	Department of Public Works, Division of Facility Services entered into a Contract, known as
7	the 2023 On-Call HVAC Contract, with Automatic Controls Equipment Systems, Inc., and
8	Sheet Metal Contractors, Inc., for \$100,000.00 per term; and,
9	WHEREAS, Ordinance 24-0157 for Change Order No. 1 was approved to add
10	\$75,000.00 to the contract; and
11	WHEREAS, the Department of Public Works, Division of Facility Services of
12	Jefferson County, Missouri finds that it is now necessary to adjust the estimated amount of
13	the 2023 On-Call HVAC Contract; and
14	WHEREAS, the need for the adjustment is due to an emergency repair at the jail;

16	WHEREAS, the walk-in freezer in the jail that stores food for the inmates needs
17	major repairs; and
18	WHEREAS, Jefferson County, Missouri and the Department of Public Works,
19	Division of Facility Services for Jefferson County, hereby request an increase of an

4	in the best interest of the County to execute Change Order No. 2 to the 2023 On-Call HVAC				
5	Services Contract with Automatic Controls Equipment Systems, Inc., and Sheet Meta				
6	Contractors, Inc., for an increase of Twenty-Five Thousand Dollars (\$25,000.00) to the				
7	contract sum, subject to budgetary limitations; for a revised total of Two Hundred Thousand				
8	Dollars (\$200,000.00) for the 2023 On-Call HVAC Services Contract upon approval.				
	BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,				
	AS FOLLOWS:				
9	Section 1. The Contract with Automatic Controls Equipment Systems, Inc., and				
10	Sheet Metal Contractors, Inc., for the 2023 On-Call HVAC Services Contract shall be				
11	increased by Twenty-Five Thousand Dollars (\$25,000.00) for a revised total cost of Two				
12	Hundred Thousand Dollars (\$200,000.00), subject to budgetary limitations.				
13	Section 2. The Jefferson County, Missouri, Council hereby authorizes the County				
14	Executive to execute Change Order No. 2 to the 2023 On-Call HVAC Services Contract with				
15	Automatic Controls Equipment Systems, Inc., and Sheet Metal Contractors, Inc., and any				
16	agreements or contracts necessary to effectuate the award of the bids and proposals set forth				
17	in this Ordinance. The County Executive is further authorized to take any and all actions				
18	necessary to carry out the intent of this Ordinance.				
19	Section 3. Copies of all Invitations for Bid, response thereto, any contract				
20	agreements and change orders shall be maintained by the Department of the County Clerk



- 1. To disconnect and remove the existing evaporator and condensing unit for walk in freezer.
- 2. The existing walk in Freezer cabinet and refrigerant line set to remain in place.
 - **a.** Jefferson County to seal entire freezer cabinet. Smci not responsible for equipment and cabinet freezing up
- 3. Then to furnish and install a new Bohn I evaporator and a new Heatcraft condensing unit.
- **4.** The existing refrigerant lines will be flushed with a refrigerant flushing solution, pressure tested, then reconnected to the new equipment.
- **5.** The existing power wiring, control wiring and drain line will be reconnected to the new equipment adapting as required to make connections.
- 6. Rework and us exsiting condensing unit stand
- 7. A complete start up and check of the new equipment operation.
- 8. 1 year labor warranty, 1 year parts warranty, 5 year compressor warranty.
