1 **AN ORDINANCE TO AUTHORIZE THE COUNTY EXECUTIVE TO**
2 **EXECUTE CHANGE ORDER NO. 3 FOR THE JAIL SECURITY CONTROLS**
3 **CONTRACT FOR THE JEFFERSON COUNTY, MISSOURI.**

4 **WHEREAS,** Pursuant to Ordinance 19-0353 Jefferson County, Missouri entered into
5 a Contract, known as the Jail Security Controls 2019 Contract, with Electronic Contracting
6 Company; and

7 **WHEREAS,** Pursuant to Ordinance 20-0149 Change Order No. 1 was approved to
8 extend the one-year maintenance agreement to a five-year maintenance agreement; and

9 **WHEREAS,** Ordinance 24-0160 Change Order No. 2 was approved to cover the cost
10 of repairs; and

11 **WHEREAS,** the Department of Public Works of Jefferson County, Missouri finds
12 that it is now necessary to adjust the estimated amount of the Jail Security Controls 2019;
13 and

14 **WHEREAS,** the need for the adjustment is to cover the cost for several repairs that
15 have been necessary over the years that were over basic maintenance and annual fees; and

16 **WHEREAS,** Jefferson County, Missouri and the Department of Public Works for
17 Jefferson County, hereby request an increase of an additional Ten Thousand Dollars
18 **(\$10,000.00)** to the Jail Security Controls 2019 Contract with Electronic Contracting
19 Company to cover the cost to complete the remainder of the security system contract; and,

1 **WHEREAS** Jefferson County, Missouri, Council finds that it is now necessary and
2 in the best interest of the County to execute Change Order No. 3 to the Jail Security Controls
3 2019 Contract with Electronic Contracting Company, for an increase of Ten Thousand
4 Dollars (**\$10,000.00**) to the contract sum, subject to budgetary limitations; for a revised total
5 of Two Hundred Seventeen Thousand, One Hundred and Nine Dollars, (**\$217,109.00**) for
6 the Jail Security Controls 2019 Contract upon approval by the County Council and County
7 Executive.

**BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,
AS FOLLOWS:**

8 Section 1. The Contract with Electronic Contracting Company for the Jail
9 Security Controls 2019 Contract shall be increased by Ten Thousand Dollars (**\$10,000.00**)
10 for a revised total cost of Two Hundred Seventeen Thousand, One Hundred and Nine
11 Dollars, (**\$217,109.00**), subject to budgetary limitations.

12 Section 2. The Jefferson County, Missouri, Council hereby authorizes the County
13 Executive to execute Change Order No. 3 to the Jail Security Controls 2019 Contract with
14 Electronic Contracting Company, and any agreements or contracts necessary to effectuate
15 the award of the bids and proposals set forth in this Ordinance. The County Executive is
16 further authorized to take any and all actions necessary to carry out the intent of this
17 Ordinance.

18 Section 3. Copies of all Invitations for Bid, response thereto, any contract
19 agreements and change orders shall be maintained by the Department of the County Clerk

1 consistent with the rules and procedures for the maintenance and retention of records as
2 promulgated by the Secretary of State.

3 Section 4. This Ordinance shall be in full force and effect from and after its date
4 of approval. If any part of this Ordinance is invalid for any reason, such invalidity shall not
5 affect the remainder of this Ordinance.
