AN ORDINANCE FOR THE PURPOSE OF ANNEXING UNINCORPORATED AREA INTO THE CITY OF JONESBURG, MISSOURI WITHOUT FURTHER ACTION.

WHEREAS, a verified petition requesting annexation and signed by the owners of all fee interests of record in all tracts of real property located within the area hereinafter describes and proposed to be annexed was received on March 4, 2024.

WHEREAS, said acres are unincorporated which are contiguous and compact to the existing corporate limits of the City of Jonesburg as provided in Section 71.012 RSMo, and

WHEREAS, a public hearing concerning the matter was held at the City Hall of Jonesburg, Missouri, at 6:00pm April 1, 2024 not less than fourteen nor more than sixty days after petition was received, and

WHEREAS, notice of public hearing was published in the Montgomery Standard, a newspaper of general circulation qualified to publish legal matters on March 13, 2024 which date is not less than seven days after notice of hearing, and

WHEREAS, at the public hearing any interested person, corporation or public subdivision could present, evidence regarding the proposed annexation, and

WHEREAS, no written objection to the proposed annexation was filed with the Board of Alderpeople of the City of Jonesburg, Missouri within fourteen days after public hearing.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERPEOPLE OF THE CITY OF JONESBURG, MISSOURI, AS FOLLOWS:

SECTION 1. The Board of Alderpeople of the City of Jonesburg, Missouri, does hereby determine that the proposed annexation is reasonable and necessary to the property development of the City and the City has ability to furnish normal municipal services to the area to be annexed within a reasonable time.

SECTION 2. The Board of Alderpeople of the City of Jonesburg, Missouri, does hereby annex said unincorporated which are contiguous and compact to the existing corporate limits of the City and extend is limits to include the territory lying in the County of Montgomery, State of Missouri, and described as follows, to-wit:


