AN ACT to delete the contents of Chapter 178 Erosion and Sediment Control, Chapter 182 Floodplain Management, Chapter 185 Forest Conservation, and Chapter 215 Subdivision of Land in the Public Local Laws of Kent County, Maryland, and to indicate that these Chapters are "Reserved" to reflect actions taken in 2002, whereby the contents of these Chapters were relocated to Chapter 222 Zoning of said Public Local Laws by adopting the Kent County Land Use Ordinance as a unified development ordinance.


**BE IT FURTHER ENACTED** by the County Commissioners of Kent County that this Act shall take effect on the 2nd day of June, 2023.




