ORDINANCE 2022 - 3

AN ORDINANCE OF THE TOWN COUNCIL OF THE MUNICIPALITY OF KINGSTON, LUZERNE COUNTY, PENNSYLVANIA, A HOME RULE MUNICIPALITY, AMENDING SECTION 170–25 OF THE MUNICIPAL CODE TO PROHIBIT PARKING ON THE SOUTH SIDE OF PIERCE STREET FOR A DISTANCE OF FORTY THREE FEET FROM THE INTERSECTION OF PIERCE STREET WITH RIDGE AVENUE

WHEREAS, the Municipality of Kingston has heretofore enacted various ordinances as amended from time to time, to promote and provide for the regulation of vehicular traffic and enhance traffic safety within the Municipality; and,

WHEREAS, the improvement of safety within the Municipality is a goal of the Mayor and Council of this Municipality; and,

WHEREAS, Section 170-25 of the Kingston Municipal Code regulates and prohibits parking at certain locations within the Municipality of Kingston to assist in meeting these objectives; and,

WHEREAS, the prohibition of parking for a distance of forty-three (43) feet on the south side of Pierce Street from its intersection with Ridge Avenue would provide a better sight line for motorists traveling on Ridge Avenue attempting to turn onto Pierce Street;

WHEREAS, the enactment of said parking prohibition would not adversely affect other residents or businesses in the vicinity.

NOW THEREFORE, BE IT ORDAINED that the Town Council of the Municipality of Kingston does hereby amend the Municipal Code as follows:

- 1. Municipal Code Section 170-25 is amended to prohibit parking on the south side of Pierce Street for a distance of forty-three (43) feet from the intersection of Pierce Street with Ridge Avenue.
- 2. This amendment may be incorporated into the Code in the following format:

Street

Pierce Street

Side

South

Limits

From the intersection of Ridge Avenue and Pierce Street for forty-three (43) feet west.

- 3. The placement of appropriate approved signage at said location is hereby authorized and directed.
- 4. The provisions of this Ordinance are declared to be severable, and if any section, sentence, clause or phrase of this Ordinance shall be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses or phrases of this Ordinance, but the same shall remain in full force and effect, it being the intent that this Ordinance shall stand, notwithstanding the invalidity of any part thereof.
- 5. This Ordinance shall become effective in conformity with Kingston Charter Section 213.
