

RESOLUTION 2023 – 14

A RESOLUTION OF THE TOWN COUNCIL OF THE MUNICIPALITY OF KINGSTON, LUZERNE COUNTY, PENNSYLVANIA, A HOME RULE MUNICIPALITY, APPROVING THE REAPPOINTMENT OF NANCY COOPER, ROBERT JACOBS, ROBERTA ROWLANDS TO THE BOARD OF DIRECTORS OF THE HOYT LIBRARY AND, FURTHERMORE APPOINTING WILLIAM HARDWICK AND JAMES J. HAGGERTY, ESQ. TO SAID BOARD

WHEREAS, the membership of the Hoyt Library Board is governed by Section 21-2B of the Ordinances of the Municipality of Kingston; and,

WHEREAS, appointments are made by nomination of the Mayor to the Town Council, who may approve the recommended appointment by a majority vote; and,

WHEREAS, the Honorable Jeffrey Coslett, Mayor of the Municipality of Kingston has reappointed Nancy Cooper, Councilperson and Roberta Rowlands, Councilperson for one (1) year terms to expire December 31, 2024 as members of the Board of Directors of the Hoyt Library; and,


WHEREAS, The Honorable Jeffrey Coslett has, furthermore, nominated William Hardwick, Wyoming Valley West School Board Member, to a term to expire December 31, 2026 and James J. Haggerty, Esq., Friends of the Hoyt Library to terms to expire December 31, 2026; and,

WHEREAS, it is noted that Mayor Jeffrey Coslett is automatically a member of the Board of Directors of the Hoyt Library by virtue of his position as Mayor of the Municipality of Kingston for a term to expire December 31, 2026 and Robert Jacobs is a member of the Board by virtue of his position as President of Council for a term to expire December 31, 2026.

NOW THEREFORE, the Town Council of the Municipality of Kingston does hereby approve the reappointment of Nancy Cooper, Councilperson and Roberta Rowlands, Councilperson to one (1) year terms to expire December 31, 2024 as members of the Board of Directors of the Hoyt Library. The Town Council furthermore appoints William Hardwick, Wyoming Valley West School Board Member, to a term to expire December 31, 2026 and James J. Haggerty, Esq., of the Friends of the Hoyt Library to a term to expire December 31, 2026. Mayor Jeffrey Coslett is automatically a member of the Board of Directors of the Hoyt Library by virtue of his position as Mayor of the Municipality of Kingston for a term to expire December 31, 2026 and Robert Jacobs, Council President is a member of the Board by virtue of his position as President of Council for a term to expire December 31, 2026.
