Mary McGinley, 283 North Sprague Avenue as a member of the Citizens Advisory Commission for a three-year term to expire on December 31, 2025.


Terri Nowak, 25 North Thomas Avenue as a member of the Citizens Advisory Commission for a three-year term to expire on December 31, 2025.
